
# Day 1: Innovations for entrepreneurship and the integration of the informal sector Welcome and breakfast



H. E. Dr Rania El Mashaat, Minister of International Cooperation for Egypt




He holds a Master's degree from Paris-Sorbonne University and is pursuing a remote PhD on "Innovation and Employment in the Arab world" at the United Nations University.
